ones A lot of women got married and had children after the war, and they generally stopped working after that The marriage age dropped dramatically -- young people were rushing into marriage, and a larger percentage of people married than ever before People began having children at a younger age Nearly everybody got married and had children

**Social Security for Married Couples - AARP**

Married couples should carefully consider their choices before claiming Social Security benefits, because this decision can have long lasting effects on their financial security Couples should keep in mind that waiting until full retirement age or even longer will significantly boost the monthly income they receive from Social Security

**Social Security for Divorced Couples - AARP**

If your ex-spouse is deceased, you may still be able to collect benefits based on your ex-spouse's work record under the following rules: Q You must be age 60 (age 50 if you're disabled) Q If you remarry before you reach age 60 (or age 50 if disabled), you cannot receive survivor benefits as long as that marriage remains in effect
